## Things to Remember...

- For those students who ride the bus...in order to assure the safety of your child each day, it is imperative to notify the school and your child's teacher if your child will not be riding the bus home on any particular day. Please send a note stating that your child will not be riding the bus that day. If a note is not sent to school, your child will be sent home on the bus. We appreciate your cooperation in this matter.
- Just a few words about clothing for school. Shorts are permitted, but must be of appropriate length. The "fingertip test" is a good indicator. Spaghetti straps, halter tops, midriffs, half shirts, and shirts with inappropriate messages or double meanings are not allowed. If a student arrives at school with inappropriate clothing, the parent will be called to bring a change of clothes, or a t-shirt will be provided to the child.
- As in years past, we continue to collect and recycle used computer printer cartridges. They can be either from laser printers or inkjet printers. There is a box in our front entry way where you can place them. We will also continue to collect Box Tops for Education. Thank you in advance for helping in this way.
- With regard to our lunchroom rules, children are not permitted to bring any soda pop or fast food (i.e., McDonald's) for lunch. Your cooperation is greatly appreciated.
- Lawn Care Application Notice—Parents/Guardians should be aware that School District #109 applies lawn care products in order to maintain a beautiful campus of which all of us can be proud. With that being said, by law, our school must maintain a registry of all parents/guardians of students that wish to be notified prior to the application of pesticides to school grounds.
